### SECTION 2 – HAZARDOUS IDENTIFICATION

**EMERGENCY OVERVIEW:** This is a personal care or cosmetic product that is safe for consumers and other users under intended and reasonably foreseeable use.

#### POTENTIAL HEALTH EFFECTS:
